RECOMMENDED ACTION

Staff recommends that the Senior Citizens' Advisory Board (S.C.A.B.) receive and file this program update.

SUMMARY

- Senior Center Expansion Update: The bids for the contractor are currently under review. We anticipate selecting a contractor by October, with a groundbreaking ceremony planned for late October and construction commencing in November. The goal is to complete the construction between October and December of 2025.
- Senior Center attendance June 2024: 3,457, averaging 181, July 2024: 4,198, averaging 199 per day, August 2024: 4,365 averaging 198 per day. (May 2024: 4,103)
- Senior Center Membership end of July 2024: 3,895, August 2024: 4,024
- Meals Delivered in July 2024, August 2024: 2,800 to 400 seniors, averaging 100 seniors per week.
- Hot Lunches served June 2024: 1,857 averaging 97 per day, July 2024: 2,295 averaging 109 per day. August 2024: 2,870 averaging 130 per day. (May 2024: 2,222, averaging 101 per day)
- FSA has continued the Take Home Meals on weekends for seniors.
- Feeding America distributed (400 food boxes of non-perishable food boxes on July 11, August 8 and September 12, 2024, Senior Center continues to lead the I.E., in boxes distributed to seniors.
- Senior Center continues to stay open as a cooling center when temperatures go above 98 degrees.
- Senior Center's banquet room continues to average two banquet rentals a month and two church rentals every Sunday.
- Healthcare Agencies will be on site at the Senior Center as open enrollment approaches.
- Friends of Moreno Valley continues its partnership with the Salvation Army to provide 36 seniors with perishable food items. Distribution will be every Friday.
- Friends of Moreno Valley continues providing free shuttle service to seniors for all medical and grocery needs as well as free coffee.
- Haircuts continue to be full at the senior center every Tuesday. Appointment required.
- Headsets continue to be available for all meetings for hard of hearing and/or translation as needed. Translation Requests must be submitted at least 72 hours prior to need.
- CPR class resumed on September 6, 2024.
